#### Overview

The Certificate in Strategic Trade at George Mason University's Schar School of Policy and Government operates at the intersection of global commerce and international security. This active field addresses the use of trade sanctions, defense, and dual-use trade controls to manage modern security threats. Demand for expertise in strategic trade is expanding in the private sector (trade compliance), government (licensing, enforcement, intelligence), and in higher education (implementation of government programs).

The Schar School Certificate in Strategic Trade will prepare new professions for this environment and help more seasoned professionals update their understanding of the field. Consisting of only five courses, this is an affordable means of advancing your career by earning a credential from one of the top-ranked policy schools in the U.S.
